JUNIOR FAIR RULES AND REGULATIONS

1. All entries in the Junior Fair Division will be accepted at the Expo Office at 4921 Expo Drive, Manitowoc, Phone 920-683-4378, on or before June 27, 2008. Mailed entries, if necessary, must be postmarked no later than June 27, 2008, and must include the \$2.50 Exhibitors Fee. All Junior Fair exhibitors must purchase a \$2.50 Exhibitor Ticket.
2. All exhibitors in the Junior Fair Division must be residents of Manitowoc County belonging to or members of 4-H, FFA, FHA-Hero, Scouting programs, breed groups or other recognized youth organizations under adult leadership and with an education program approved by the local Fair. A junior fair exhibitor must be under 20 years of age and have completed any school grade at or below grade 13 prior to June 27 of 2008.
3. The exhibitors who exhibit at Fair MUST be enrolled in and list the projects.
4. Individual conference judging will be done for each Junior Fair exhibit - give special attention to entry dates, judging dates and time, and release dates and time.
5. Securely attach the correct entry tag to the upper right hand corner of the exhibit.
6. Exhibits must be the result of the members own labor.
7. **Livestock exhibits must be shown by the Junior Fair Exhibitor. Adults will not be permitted to show for a Junior Fair exhibitor.**
8. All possible care to prevent loss or damage to articles exhibited will be taken, but no responsibility for the same will be assumed.
9. All exhibits in the Junior Fair Division will be subject to the general overall rules of the Fair management including release times.
10. Junior Fair exhibitor who do not follow the rules for entering their item(s) in the Junior Fair Division will receive and explanation of the violation on judging day, followed by an automatic placement of a 4th place ribbon award and premium.
11. Any exhibitor with any law violations on Expo grounds during the Fair will carry a penalty of one (1) year suspension of Fair exhibiting. This is retroactive to the 1990 Fair.
12. Merit awards will be awarded for each 100 entries in each Department. A merit award can be awarded to one exhibitor in the same department for 3 consecutive years.
13. **Junior Fair exhibitors are not allowed to show in Junior Fair and then enter into Open Class.**
